Claim (once per year)

Filing for Unemployment Benefits

(Temporary Employees <u>must</u> Contact the State of Michigan to file a Claim)

Based on your communication election After the claim is filed the State will notify you of WHEN TO CERTIFY

by sending you a letter in the mail
Or
by posting the information on
your **MiWAM** account.





Michigan Web Account Manager

Benefit Period is for 1 year. It starts when you open a Claim. There are twenty weeks of benefits in 1 year.

Monetary Determination – Form UIA 1575C has important information. This was sent to you. Keep it for reference.

Certifying (up to 20 weeks per year)

Following the date(s) included in the State's Instructions, YOU MUST CERTIFY to receive Unemployment Benefits.

Certifying using MiWAM is the quickest way to receive your State Benefits:



Use MiWAM by going to:
www.michigan.gov/uia
Click on the MiWAM logo to
access your MiWAM account.

When certifying you will be asked a series of questions about the week(s) you are claiming. The weeks the State asks about will vary. Your FCA pay stub lists Benefit Period start and end dates.

Note: this is a single example from an FCA pay stub.

Benefit Period: February 11, 2019 - February 17, 2019

In General the State will ask about a benefit period beginning on a Sunday and ending on a Saturday. In the above example, if you had earnings from 02/11/2019 – 02/17/2019, you would report those earnings in your State claim in benefit period 02/10/2019 - 02/16/2019.

Note: if you did not work you may not have a pay stub. Holiday Pay counts as earnings.

Important Things About Certifying

Earnings and pay are not limited to your FCA work earnings and are from any employer. When asked about pay or earnings for the time period, report your Gross earnings. Look in the Earnings section at the Total line. In this example it is \$489.80

If you have pay for the period answer "yes". Your Monetary Determination

will be used to calculate your State benefit. The more you earn in the benefit week, the less your State benefit will be.

- If you have zero hours worked you may not find a stub in ePay.
- You have 20 weeks of State benefit in a vear.

Caution: If you have earnings and you answer NO you will collect full benefits you are not entitled to. You may be called to the Employment Office for discipline up to and including termination.

Below are the questions the State will ask you about the Benefit Week you are claiming. Pay close attention to the dates in the questions. Question 14 and 15 are related to your FCA Pay. If you have pay, any dollar amount on your FCA check or from any other employer you just answer 'YES'.

Caution: If you have earnings and you answer NO you will collect full benefits you are not entitled to. You may be called to the Employment Office for discipline up to and including termination.



In order to get paid UI benefits, employees have to correctly answer to get benefits.

Michigan MiWAM and MARVIN's New Script:

- 1. Has your address changed since your last certification?
- Are you claiming the week beginning Sunday, (date) through Saturday, (date)?
- 3. Were you available to accept full-time work every day from Sunday, (date) through Saturday (date)?
- 4. Were you able to work full-time every day between Sunday, (date) through Saturday (date)
- 5. Did you look for work during the week Sunday, (date) through Saturday (date)?
- 6. Did you quit any job between Sunday, (date) through Saturday (date)?
- 7. Did you refuse any job(s) or offer(s) of work between Sunday, (date) through Saturday (date)?
- 8. Were you fired from any job between Sunday, (date) through Saturday (date)?
- 9. Did you BEGIN attending school or training classes Sunday, (date) through Saturday (date)?
- 10. Did you begin receiving a pension between Sunday (date) through Saturday (date)?
- 11. Did you receive vacation pay between Sunday, (date) through Saturday (date)?
- 12. Did you receive, or will you receive holiday pay for a holiday that occurred from Sunday, (date) through Saturday (date)?
- 13. Did you receive severance pay between Sunday (date) through Saturday (date)?
- 14. Did you do any type of work for pay or promise to pay between Sunday, (date) through Saturday (date)?
- 15. Did you have any earnings between Sunday, (date) through Saturday (date)?
- 16. Did you return to work full-time between Sunday, (date) through Saturday (date)?
